World Association of Investment Promotion Agencies (WAIPA), Maison Internationale de
l'Environnement 2 (MIE2) 9, Chemin de Balexert 1219 Châtelaine / Geneva - Switzerland
(hereinafter « WAIPA »)

WHEREAS the PROMPERÚ wishes to join WAIPA as a member pursuant to the terms and
conditions as provided for in WAIPA statutes,

WHEREAS WAIPA is happy to welcome the PROMPERÚ as one of its members,

NOW, THEREFORE, the parties agree as follows:

1. Membership of the PROMPERÚ.

PROMPERÚ applies to become a member of WAIPA pursuant to the terms and conditions as
provided for in WAIPA statutes (the "Statutes") that have been handed over to the PROMPERÚ.

PROMPERÚ accepts and undertakes to conform to the terms and conditions of the Statutes.

2. Approval of membership.

The Permanent Secretariat has examined the application of the PROMPERÚ to become a member
of WAIPA and approves such membership.

2. Membership fees.

PROMPERÚ undertakes to pay the membership fees for the year 2023. The total amount due is
USD 5'000* and shall be paid within 10 days of the signature of this Protocol.

**Please note that the bank transfer and 30% withholding tax, as required by Peruvian legislation, will be reflected in
the membership amount as total \$7,142.86 USD.*

In addition, from the moment of signature of this Protocol, the PROMPERÚ will duly pay the yearly membership fees amounting to USD 5'000.

4. Rights and obligations of the parties.

Once the current membership fees have been duly paid, the Permanent Secretariat shall publicize the new admission of the PROMPERÚ.

From that moment, PROMPERÚ will be entitled to all rights and bound by the duties and obligations of WAIPA members as outlined in the statutes, as well as having exclusive access to the **Membership Platform** (WAIPA Members Portal), where WAIPA members can instantly promote their work and events and communicate with other fellow IPAs.

PROMPERÚ is permitted to use the WAIPA logo on its website with the consent of WAIPA.

5. Miscellaneous

This Protocol sets forth the entire agreement between the parties and supersedes all previous agreements, written or oral. It may be amended only in writing.

This Protocol shall be construed in accordance with the laws of Switzerland. Any dispute between the parties shall be submitted to the Courts of Geneva exclusively.
